2024 Year in Review

Tempe IGA

On 12/11/2024, the cities of Phoenix and Tempe signed an agreement amending the 1994 IGA, effectively ending the ongoing litigation stemming from Phoenix’s suit filed in 2023 over Tempe’s approval of incompatible development projects within the 65 DNL noise contour area.

FAA PBN Working Group

In Spring 2022, the FAA kicked off a Performance-Based Navigation Working Group to address efficiency and safety improvements in our region’s terminal and en route airspace. Conceptual changes were identified in 2024; public outreach is expected to occur throughout 2025, and the current publication date for the procedures is September 2026.

GYR Fly Friendly Signage

In 2024, Aviation installed airfield signage reminding pilots to fly friendly, especially staying south of I-10 during pattern work to mitigate aircraft noise.

West Valley Amazon Drone Delivery

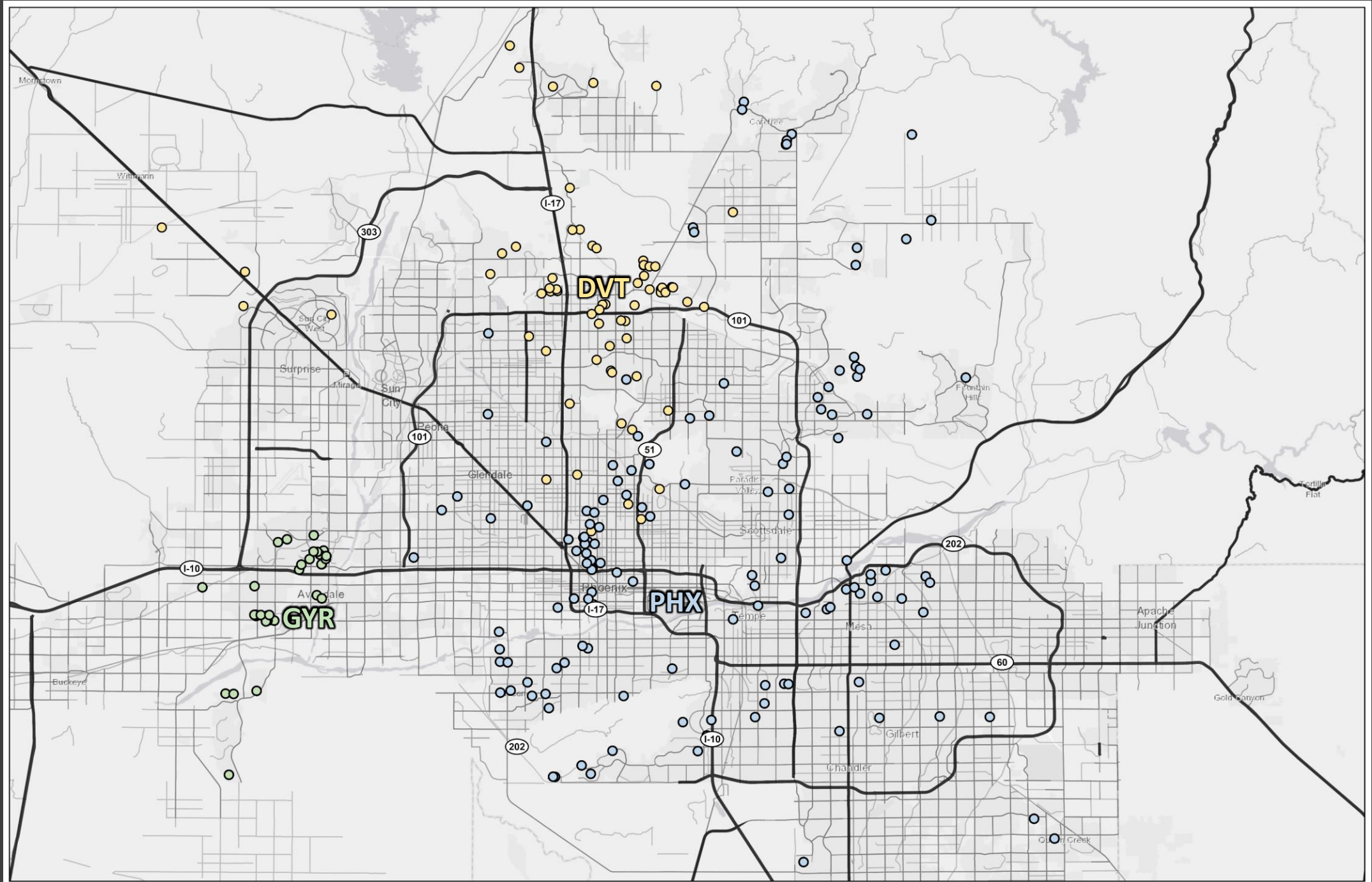
# Map of 2024 Complainant Households

## Complainant Airport

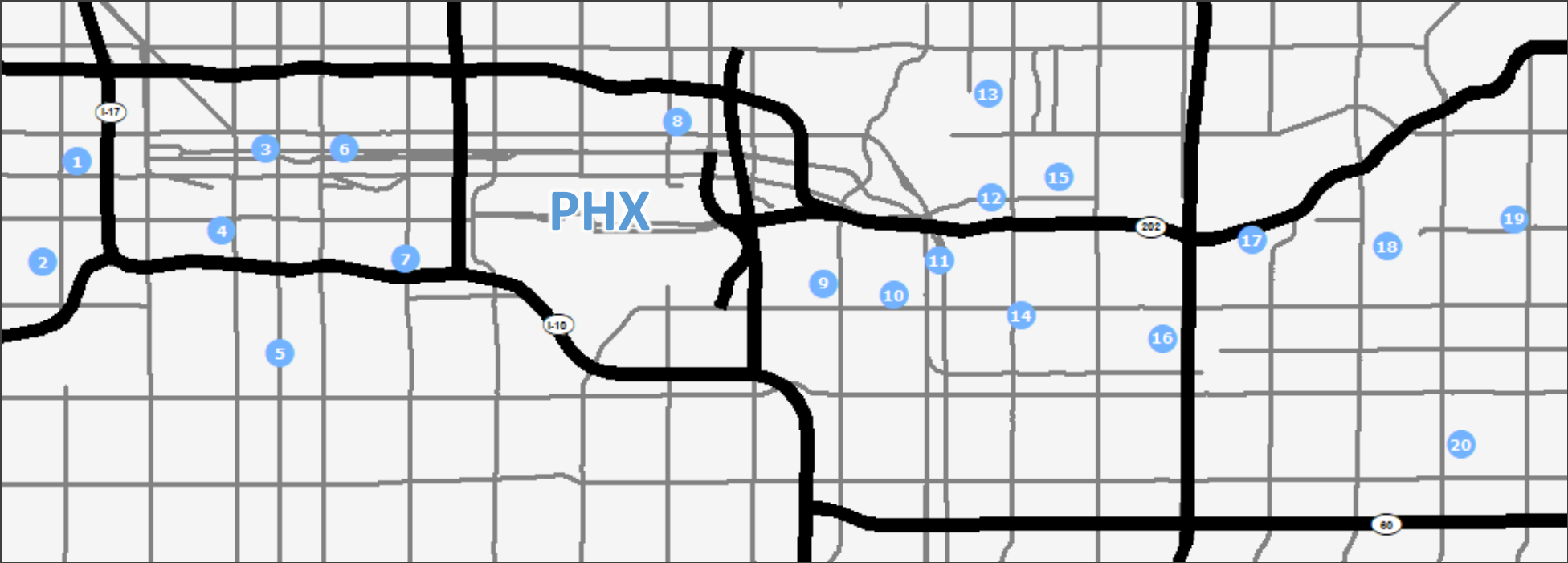

# Sky Harbor Noise Abatement Performance

## Departure Corridor Equalization

To minimize community impacts from overflight, Phoenix works with the FAA to ensure departures from Sky Harbor are balanced in terms of east and west flows over the calendar year.

## Departure Gate Compliance

To minimize community impacts from overflight, Phoenix works with the FAA to ensure departures from Sky Harbor do not turn out of the Salt River compatibility corridor earlier than necessary. In east flow operations, the turn “gate” aligns with the Loop 101 freeway. In west flow operations, the turn “gate” aligns with 43<sup>rd</sup> Avenue. The compliance percentage measures the relative number of jet aircraft departures that did not turn before the gate (i.e., remained inside the compatibility corridor).
